Introduction

Tam sim no koj tau raug Department of Homeland Security (DHS) ntes. DHS hais tias koj tsis muaj cai nyob hauv teb chaws Meskas thiab koj yuav tsum tau tawm hauv lub teb chaws no.

Muaj ob peb txoj kev uas DHS muab koj tshem tawm ntawm lub teb chaws no tau. Daim ntawv no yog tshwj xeeb rau cov tib neeg uas tus rau ntsib ib tug kws tu plaub lawm.

Yog tias koj tau txais ib daim ntawv hu ua “Notice to Appear” txhais tau hais tias koj yuav tau mus ntsib ib tug kws tu plaub xav saib seb koj puas mag laij tawm teb chaws.

Yog hais tias koj tau mag ntes kaw yuav rov qab mag xa mus rau koj lub tebchaws, yeej muaj ob peb yam uas koj tau ua txhaum lawm.

Yog tias koj tsis tau txais ib daim ntawv hu ua “Notice to Appear” txhais tau hais tias tej zaum koj:

- Tau raug DHS ntes ntawm ciamb tes los yog pem tshav nyob hoom
OR
- Koj rov qab nkag los hauv teb chaws Meskas tom qab lawv twb muab koj ncaws tawm lawm

OR

- Koj tau txhaum cai loj thiab tsis muaj daim npav ntsuab nyob hauv lub teb chaws no

Yog tias koj nyob ntawd no lawm, txhais tau hais tias tej zaum koj yuav tsis tau ntsib ib tug kwv tu plaub thiab tej yam lus xov xwm hauv phau ntawv no yuav tsis tseem ceeb rau koj.

Yog tias koj tau kos npe rau ib tsab ntawv hais tias koj pom zoo rov qab mus rau koj lub teb chaws thiab tsis xav ntsib ib tug kws tu plaub, lawv yuav pib ua ntaub ntawv xa koj rov qab.

Yog hais tias koj tsis tau ua dab tsi txhaum cai thiab koj tsis tau txais daim “Notice to Appear” koj yuav tsum nug tus tub ceev xwm DHS saib koj mag ntes ua dab tsi.

Yog tias DHS hais tias koj nyob tsis tau hauv lub teb chaws no vim hais tias koj tsis muaj tso cai nyob.

Yog tias koj yeej muaj npav ntsuab los yog ib daim VISA ua cia koj nyob hauv lub teb chaws no tab sis DHS hais tias koj tau ua txhaum cai lawm ua lawv yuav tsis pub koj nyob lawm.

The Court Process

Muaj peb Yam kev txiam txim plaub rau cov tib neeg khiav teb chaws ua yuav raug xa rov qab: “master calendar hearing” yog thaum cov tib neeg uas ua hauj lwm rau tus kws tu plaub ntsuam xyuas saib puas muaj pov thawj txaus uas rov qab xa koj. No yog thaum koj yuav tsum tau ua ntaub ntawv kom tiav, lawv muab sij hawm rau koj nhriav ib tug kws lij choj thiab qhia koj tias hnub twg yog koj hnub kawg uas koj tau nyob hauv teb chaws Meskas, thiab tej thaum cov tib neeg ua hawlwm rau tus kws tu plaub txiav txim siab hais tias lawm yuav ua li cas rau koj. “Bond hearing” yog thaum tus kws tu plaub saib seb nws cia koj them nyiaj nyob tos lawv txiam txim seb lawv puas xa koj rov qab mus koj lub teb chaws. Tej cov bond hearing kuj nyob nrog tib hnub uas “master hearing” thiab. “Merits hearing” yog thaum tus kws tu plaub mloog ob tog lus pov thawj tag seb puas muab koj xa rov qab los tsis xa.

Thaum koj mus rau koj qhov “Master Hearing” thawj zaug, tus kws tu plaub yug piav qhia koj cov cai rau koj. Koj muaj cai ntiaj ib tug kws lij choj, tab sis nom tswv yuav tsis pab koj them lossis muab ib tug rau koj. Tsis muaj cov kws lij choj uas pub dawb hauv tsev hais plaub rau cov tib neeg uas mag ntes rov qab xa. Ua ntej koj yuav mus ntsib koj tus kws tu plaub, tus tub ceevxwm DHS uas ntes koj yuav tsum muab ib daim ntawv uas muaj cov chaw uas kws lij choj ua hauj lwm t xo nqi. Yog thiaj koj tsis tau tau ib daim ntawv no, nug koj tus kws tu plaub koj nws muab koj ib daim. Yog tias koj xav thov sij hawm ntxiv kom koj nrhiav tau ib tug kws lij choj, koj yeej nug nws tau koj nws muab koj sij hawm ntxiv.

Koj thawj zaum mus ntsib koj tus kws tu plaub, nws yuav nug koj saib seb koj puas pom zoo los tsis pob zoo rau txhua yam uas DHS hais tias koj ua txhaum hauv daim ntawv “Notice to Appear (NTA).” Yog tias koj yuav raug lawv muab koj xa rov qab, DHS yuav tsum tau muaj ib daim ntawv hu li “Notice to Appear.” Daim ntaub ntawv no muaj tej yam uas DHS nrhiav tau xwb li koj qhov chaw nyob, chaw ua hauj lwm, teb chaws uas koj yug los, lub hnub tias lub hli uas koj tuaj txog teb chaws Mekas, thiab yog tias koj tau ua tej yam txhaum cai lawm. Daim ntawv no yeej yuav qhia koj hais tias vim li cas DHS xav muab koj xa rov qab.

Yog tias koj xav tias koj tsis tau txais ib daim “Notice to Appear” los ntawm DHS, koj yuav tsum nug ib tug tib neeg uas ua hauj lwm rau DHS. Yog tias lawv tsis muaj ib daim rau koj, koj yuav tsum nug koj tus kws tu plaub koj nws muaj ib daim rau koj thaum koj thawj zaug mus ntsib nws.

Thaum koj tau txais daim ntaww no lawm, qhov tseem ceeb tshaj plaws rau koj ces yog kom koj saib kom thoob rau daim ntawv no saib seb tej yam DHS sau rau daim ntawv no puas muaj tseeb. Yog tias koj xav hais tias DHS sau tsis yog lawm los yog tias koj xav pom lawv cov ntawv pov thawj, koj hais tias koj tsis leej tej yam txhaum hauv daim ntaub ntawv no yeej tau. Yog tias koj tsis leej ces DHS yuav tsum qhia tau tias vim li cas koj nyob tsis tau hauv teb chaws Meskas. Koj yuav tsum ua zoo xyuam seb DHS puas hais tias koj tau ua dab tsi txhaum cai loj (aggravated felony).

Aggravated felony yog dab tsi?

Nws yog ib lub npe ua nom tswv (Congress) tau muab tis rau tej yam kev txhaum ua rau txim hynav heev.

Muaj ob peb yam kev txhaum ua Congress tau muab tis li “aggravated felony,” tab sis cov kev txhaum ua tib neeg mag rau txim ntawv tshaj ces yog:

- *Muag tshuaj*
- *Yog tias koj tau ntaus los yog yuam lawm tus ua dab tsi es ib tug kws tu plaub tau muab koj xav mus kaw tau ib xyoo ntawv*
- *Yog tias koj nyiag dab tsi los ntawm lwm tus neeg los yog kev lag luam es ib tug kws tu plaub tau muab koj xav mus kaw tau ib xyoo ntawv*
- *Koj tau ua tej yam tsis zoo rau ib tug menyuam yaus*
- *Tua neeg los yog muab leej twg mos*
- *Kev nyiag neeg txawv teb chaws*

THOV NCO NTSOOV: Yog tias koj tau ua dab tsi txhaum cai loj lawm, koj tus kws tu plaub uas yuav hais koj rooj plaub immigration yuav hloov tsis tau koj lub txim los ntawm tus kws tu plaub uas tau muaj lub txim rau koj vim hais tias koj tau ua tej yam txhaum cai loj lawm.

Tej thaum koj yeej tig tau lub txim ua ib tug kws tu plaub (tus ua hais koj rooj plaub vim hais tias koj tau ua txhaum cai loj lawm) tau muaj rau koj. Yog tias koj xav tig lub txim, koj yuav tsum ua ntaub ntawv hu ua “motion to vacate a guilty plea” kom lub tsev hais plaub ntceev koj lub txim lossis koj yuav tsum tau thov lub tsev hais plaub koj lawm pub koj thov ua “post-conviction relief.” Post-conviction relief cia koj nug kom DHS tus kws lij choj uas ua hauj lwm rau tsoom fwv nqa pov thawj ntawv. Yog tias koj ua ntaub ntawv kom lawv ntceev koj lub txim kom koj tsis txob mag xa rov qab xwb, nws yeej lav tsis tau hais tias koj yuav nyob tau hauv teb chaws Meskas. Qhov no yeej thov nyuaj heev li. Koj yeej ua tau “gubernatorial pardon” thiab yog tias koj xav. Gubernatorial pardon yeej tshem tau koj txoj kev txhaum thiab pab koj yog tias koj xav thov ua npav ntsuab los yog ua ntawv pej xeem. Yog tias koj xav ua gubernatorial pardon, koj yug tsum tau tham nrog ib tug kws lij choj uas paub txog cov kev cai uas pab tib neeg uas tau ua tej yam txhaum cai lawm thiab yuav rov qab mag xa mus rau lawm lub teb chaws.

Yog tias tus kws tu plaub tau txiam txim siab hais tias koj yeej txhaum cai lawm, nws mam li xav seb nws puas pub koj nyob hauv teb chaws Meskas. Yog tias koj yog ib tug lawful permanent resident tab sis tau ua tej yam txhaum cai lawm, koj yeej thov ua ntaub ntawv huav li “cancellation of removal” tau. Cancellation of removal nyob rau daim nploog ntawv 11.

Ua ntej koj yuav xav seb koj puas hais koj rooj plaub los tsis hais, koj yuav tsum tau xav txog lub txim yog tias lawv muab koj xa rov qab. Xub tawm, yog tias koj mag xa rov qab, koj yuav tuav tsis tau npe ua visa lawm txawm yog tias koj tus muaj ib daim ua ntej lawm. Thib ob yog hais tias koj twb muaj ntaub ntawv uas ib tug lawful permanent resident lawm, yog tias koj mag xa rov qab, koj yuav ua ntaub ntawv rau ib daim tshiab tsis tau lawm. Peb, yog hais tias koj mag xa rov qab, koj yuav tuaj tsis tau hauv teb chaws Meskas 10 xyoo los yog thiab tsoom fwv pub koj rov qab tuaj thiab tau.

Koj yuav rov qab txhaum cai yog hais tias koj rov qab nkag los tom qab uas lawv twb muab koj xa lawm. Yog tias koj rov qab nkag los, tsoom fwv muaj cai muab koj kaw hauv nkuaj. Yog tias koj txhaum, nws yog ib qhov “federal felony” tsis yog ib qhov “misdemeanor.” Federal felony, lawv muab koj kaw tau ib xyoo los ntau hauv nkuaj. Misdemeanor yog tau lawv muab koj kaw txog ib xyoo hauv nkuaj. Yog hais tias lawv txhom tau koj, lawv yuav muab koj xa mus kaw thiab yog hais tias koj muaj aggravated felony hauv koj cov ntawb ntawv, lawv muab koj kaw tau txog 20 xyoo vim hais tias koj rov qab nyiag kev los lawm. Ntxiv tau no, yog tias koj nyiaj kev rov qab los, koj yuav tsis muaj cai ntsib ib tug kws tu plaub lawm. DHS muaj cai muab koj xa rov qab tsis pub koj ntsib ib tug kws tu plaub yog tias lawv tus muab koj xa yav dhau los lawm.

Yog tias tus kws tu plaub tau txiam txim siab hais tias nws yuav muab koj xa rov qab, koj muaj cai ua ntaub ntawv mus rau lub Board of Immigration Appeals (BIA) yog tias koj xav tias koj tsis tau ua dab tsis txhaum. Tus kws tu plaub mam li muab koj cov ntaub ntawv yog tias koj xav tsab koj rooj plaub kom BIA txiam txim siab thaum koj mus ntsib koj tus kws tu plaub rau zaum kawg. Yog tias koj tsis txaus siab rau tus kws tu plaub txoj kev txiav txim siab, koj yuav tsum tau ua daim ntaub ntawv “Notice of Intent to Appeal” thiab muaj xa mus rau BIA koj lawv txais tau 30 hnub tom qab koj mus ntsib koj tus kwv tu plaub zaum kawg.

Yog tias koj xav paub txog tej yam dab tsi nyob hauv nplooj ntawv 3-5, koj hu tau Immigration Detention Information Line of the National Immigrant Justice Center ntawm 312-263-0901. Lawv muaj sij hawm tham nrog koj tau 11am-2pm txhua txhua hnub Zwj Quag (Tuesday). Yog tias koj mag ntes yuav rov qab mag xa, koj hu tau lawv thiab hais kom DHS them nqi xov tooj rov qab rau koj tau yog hais tias koj mag kaw hauv nkuaj lawm. Koj hu tau cov chaw ua cov kws lij choj ua hauj lwm ntawm daim ntawv DHS muaj rau koj tau thiab.

Kev Ua Ntawv Pej Xeem

Tej thaum ib cov tib neeg yeej yog pej xeem Meskas lawm tab sis lawv tsis paub xwb. Pej xeem Meskas ncaws tawm teb chaws Meskas tsis tau. DHS yuav tsum muab lawv tso tawm nkuaj yog hais tias lawv yog pej xeem Meskas. Tej thaum yeej muaj cov tib neeg ua yog pej xeem Meskas los yog lawv yeej tau ua ntaub ntawv pej xeem Meskas. Yog tias koj tau teb hais tias koj yog ib tug pej xeem Meskas los yoj tias koj xav tias koj ua tau ntaub ntawv:

- Koj puas yog yug hauv teb chaws Meskas?
- Koj niam, koj txiv, los yog koj pog thiab koj yawg puas yog yug hauv teb chaws Meskas?
- Koj niam thiab koj txiv pom tau ua ntaub ntawv pej xeem Meskas ua ntes koj muab 18 xyoo?
- Koj puas tau ua hauj lwm tub rog rau teb chaws Meskas?

Yog tias koj tau teb raws li cov lus nug sau toj no 1-3, tej zaum koj yeej yog pej xeem Meskas lawm. Thaum zoo li no, koj yuav tsum tau qhia ib tug neeg uas ua hauj lwm rau DHS los yog koj tus kws tu plaub. Kev ua pej xeem Meskas nyuaj heev li, **Yog tias koj xav tias tej zaum koj yog pej xeem Meskas, koj yuav tsum tham nrog koj tus kws lij choj.** Qho tseem ceem tshaj plaws ces yog koj tau qhia thiab muab tag nrho koj cov ntaub ntawv pov thawj luam rau lawv, li ntawd DHS thiab li paub txiam txim siab saib koj puas yog pej xeem tiag tiag. Tej yam khoom uas koj yuav tsum tau qhia lawv yog: koj niam thiab koj txiv lub npe, nkawb lub hnub yug thiab teb chaws yug, thiab nkawb tau nyob hauv teb chaws Meskas

ntev npaum li cas lawm. Yog tias koj yog pej xeem Meskas, DHS muab koj ncaws tawm tsis tau teb chaws Meskas, lawv yuav tsum tau tso koj tawm.

Tib neeg uas tau ua hauj lwm tub rog hauv teb chaws Meskas thov ua pej xeem Meskas tau txawm tias DHS yuav xav xa koj rov qab. Ua hauj lwm tub rog yuav lav tsis tau hais tias koj yuav txais lais ntaub ntawv pej xeem, tab sis lawv pub koj thov ua ntaub ntawv (tiag tiag lawv yeej tsis pub tab sis koj thov tau saib lawv puas kam).

Asylum, Withholding, and Protection from Torture

Muaj peb Yam kev pov hwm uas pab tib neeg ua ntshai rov qab mus lawv lub teb chaws: “asylum,” “withholding of removal,” thiab “relief under the Convention Against Torture (CAT).” Tej zaum koj yeej tsim nyog thov tau ib los yog ob peb Yam kev pov hwm no, tab sis nws nyob ntawm seb thaum twg koj nkag tuaj hauv teb chaws Meskas, koj puas tau ua txhaum cai dab tsi, thiab koj puas muaj kev ntshai mag tua, mos, ntaus, etc yog thiab koj rov qab mus rau koj lub teb chaws. Txawm hais tias koj twb yog ib tug lawful permanent resident lawm, koj yeej muaj cai thov ob peb Yam kev pov hwm no. Yog tias koj xav ua ntaub ntawv rau ib los ob peb Yam pov hwm no, koj yuav tsum ua daim ntawv hu li “Form I-589.” Koj nug tau koj DHS los yog ib tug kws tu plaub muaj daim ntawv no rau koj. Yog tias koj yeej ntshai rov qab mag xa mus rov koj lub teb chaws, koj yuav tsum tau qhia koj tus kws tu plaub los yog ib tug tib neeg uas ua hauj lwm rau DHS yog tias koj tsis tau ntsib ib tug kws tu plaub.

Asylum

“Asylum” yog ib txoj kev ua pub koj nyob hauv teb chaws Meskas. Koj thov tau txoj kev pov hwm no yog tias koj muaj kev ntshai rov qab mus rau koj lub teb chaws los yog hais tias koj twb raug mob los ntawm laib los yog los ntawm nom tshwv. Koj txoj kev ntshai yuav tsum los ntawm laib uas tsoom fvw pab koj tsis tau los yog los ntawm nom tswv tsim txom.

- Xeem neeg
- Cov tub ntxhais kawm ntawm los yog cov tib neeg uas pab cov neeg ua mag tsim txom
- Koj yog ib tug tib neeg uas yog ib nrab poj niam ib nrab txiv neej
- Poj niam los yog txiv neej uas ntshai tsam raug kev tsim txom los ntawm lawm tus khub
- Cov poj niam uas tawm tsam tej yam coj noj coj ua
- Tib neeg uas tsis pom zoo rau lawv lub teb chaws cov nom tshwv

Yog tias muaj dab tsi saum no ua piav txog koj tab sis koj tsis xav qhia leej twg pem DHS, koj hu tau los yog sau ntawv tau rau NIJC thaum lawv muaj sjij hawm txais tos koj (11am-2pm) txhua txhua hnub Zwj Quag (Tuesday). Txhua Yam uas koj qhia rau NIJC, lawv yeej tsis qhia leej twg li. Lawv hwm thiaj tos txais txhua txhua tus tib neeg. NIJC muaj cov tib neeg uas ua hauj lwm paub pab cov tib neeg ua tau ntsib txoj kev tsim tsom lawm.

Tab sis yog hais tias koj tau kхиav koj lub teb chaws tuaj nrhiav hauj lwm xwb thiab tsis muab tej yam kev ntshai rov qab mus nyob hauv koj lub teb chaws, tej zaum koj yuav thov tsis tau asylum.

Withholding of Removal

Yog tias koj xav thov “withholding of removal” koj yuav tsum muaj lus pov thawj los yog ntaub ntawv pov thawj hais tias yog tias koj mag xa rov qab, nws yuav muaj 50 feem pua los ntau hais tias koj yuav raug kev tsim txom hauv koj lub teb chaws vim koj haiv neeg, koj txoj kev ntseeg, hom neeg, koj txoj kev xav txoj kev nom tswv, los yog kev ua ib pab ib pawg hauv zej zog.

Feem ntau, tib neeg thov “withholding of removal” thaum lawv thov tsis tau asylum. Koj thov ua ntaub ntawv “withholding of removal” tau yog hais tias koj yeej muaj kev ntshai rov qab mus nyob hauv koj lub teb chaws thiab:

Yog tias koj tau ua tej yam uas txhaum cai loj lawm, koj thov “withholding of removal” tau, tab sis nws yuav tsum yog hais koj txoj kev raug txim tsawg tshaj 5 xyoo (los ntawm koj txoj kev txhaum) thiab tus kws tu plaub tau txiam txim siab hais tias koj txoj kev txhaum tsis yog tej yam dab tsi txhawj xeeb heev.

Convention Against Torture (CAT)

Yog hais tias koj xav tias koj yuav raug nom tswv tsim txom hauv koj lub teb chaws, DHS yuav muab ib daim ntawv txawv uas koj yuav tsum ua kom tiav xa mus rau DHS. Teb chaws Meskas tus tau koom nrog lwm lub teb chaws hauv ib tsab ntawv cog lus hais tias lawv yuav tsis rov qab xa tib neeg mus rau lawv lub teb chaws yog hais tias lawv yuav mag tsim txom. Koj yuav tsum qhia koj tus kws tu plaub los yog ib tug tib neeg ua hauj lwm rau DHS yog hais tias koj muaj kev ntshai txog txoj kev tsim txom hauv koj lub teb chaws.

Yog tias koj xav paub txog tej yam dab tsi nyob ntxiv, koj hu tau Immigration Detention Information Line of the National Immigrant Justice Center ntawm 312-263-0901. Lawv muaj sij hawm tham nrog koj tau 11am-2pm txhua txhua hnub Zwj Quag (Tuesday). Yog tias koj mag ntes yuav rov qab mag xa, koj hu tau lawv thiab hais kom DHS them nqi xov tooj rov qab rau koj tau yog hais tias koj mag kaw hauv nkuaj lawm. Koj hu tau cov chaw ua cov kws lij choj ua hauj lwm ntawm daim ntawv DHS muaj rau koj tau thiab.

Credible Fear and Parole

Tom qab koj qhov credible fear interview, yog hais tias DHS tus tub ceev xwm txiam txim siab hais tias tej zaum koj ua tau ntaub ntawv thov asylum, lawv mam cia koj mus ntsib ib tug kws tu plaub. Yog hais tias DHS txiam txim siab hais tias koj thov tsis tau asylum, nws yuav rov qab muab koj xa mus, tab sis koj yeej nug tau kom ib tug kws tu plaub tshuaj xyuas saib DHS txiam txim siab puas ncaj ncees. Tus kws tu plaub yuav tsum tau tshuaj xyuas DHS txoj kev txiav txim siab tsis pub dhau 7 hnub tom qab koj qho credible fear interview.

Yog hais tias koj nyuam qhuav nkag tuaj teb chaws Meskas vim hais tias koj ntshai ntsib txoj kev tsim txom hauv koj lub teb chaws thiab koj tsis tau thov ib qho credible fear interview, koj yuav tsum thov.

Yog hais tias DHS txiam txim siab hais tias koj txoj kev ntshai mag tsim txom yeej muaj tiag, koj nug tau koj lawv tso koj dim ib ntu uas koj mam li tos lawv txiam txim siab saib lawv puas xa koj rov qab (parole). Tab sis, yog hais tias koj thov parole, koj yuav tsum muaj ib tug tib neeg txhawb nqa (sponsor) koj hais tias koj yeej muaj chaw nyob tau koj tos lawv txiam txim siab.

Cancellation of removal muaj ob yam, ib yam yog rau cov tib neeg ua tau nyob hauv teb chaws Meskas (txawm hais tias koj muaj ntaub ntawv pej xeem los tsis muaj) – ntev ntev lawm. Yam ob yog rau cov tib neeg uas muaj npav ntsuab lawm.

Cancellation of removal rau cov tib neeg ua tsis muaj npav ntsuab:

Yog hais tias koj yeej rooj plaub lawm thiab lawv tsis muab koj xa rov qab, koj ua tau ntaub ntawv thov npav ntsuab lais.

Koj yuav tsum ntsib plaub yam uas koj toob kas ua ntej koj thov tau cancellation:

Daim “T” thiab “U” visa pub koj ua hauj lwm thiab ua ntaub ntaww hais tias koj muaj cai nyob hauv teb chaws Meskas ib ntus. Koj yeej muaj cai thov kev pab cuam los ntawm tsoom fwv hauv lub zos koj nyob. Ib ntus tag, lawv mam li cia koj ua ntaub ntaww npav ntsuab. Tej thaum koj tus poj niam, tus txiv, koj cov me nyuam, tij laug thiab nkauj muam, los yog koj niam thiab koj txiv yeej tau kev pab los ntawm koj daim “T” visa los yog koj daim “U” visa thiab.

Nyiag tib neeg ua lag luam thiab ua qhev – “T” visa

Thaum laib nyiag tib neeg ua lag ua luam txhaum cai loj hauv teb chaws Meskas yog thaum lawv ua txhaum cai hais tias tib neeg muab tib neeg ua qhev tsis tau, muab lawv ua hauj lwm them nuj nqis rau lawv, los yog hais tias koj tau mag yuam ua hauj lwm. Koj yog ib tug tib neeg uas tau raug kev tsim txom los ntawm laib yog hais tias lawv (cov laib) tau:

Voluntary departure yeej muaj tej yam zoo thiab. Yog hais tias koj thov

voluntary departure, lawv yuav tsis sau cia hais tias koj yeej mag xa rov qab lawm los yog hais tias koj muaj ib qhov order of removal hauv koj cov ntaub ntawv nkag teb chaws (immigration file). Yog hais tias yav tom ntej koj xav rov qab tuaj rau hauv teb chaws Meskas, koj yuav tsis ntsib teeb meem ntau, thiab qhov no yeej pab tau koj mus ntsib thoob ntiaj teb yog hais tias koj xav mus ncig ua si.

Bond Re-Determination Hearing

Txawm tias DHS tau muab koj ntes lawm los koj yeej thov tau tus kws tu plaub saib nws puas pub koj them ib qhov bond ua pub koj nyob pem tsev tos lawv rov qab hu koj mus peb tsev hais plaub tau lawv npaj txhij txiam txim saib koj nyob puas thaum hauv teb chaws Meskas. Yog hais tias koj tau mag ntes lub sij hawm uas koj nyiag kev tuaj, tus kws tu plaub yuav pub tsis tau koj them bond tab sis koj yeej thov tau parole. Feem ntau, yog hais tias koj tau ua tej yam txhaum cai lawm, koj yuav thov tsis tau them bond, yog li ntawd koj yuav tsum nyob hauv tsev kaw nkuaj tos koj hais koj rooj plaub thiab lawv txiam txim siab saib lawv puas pub koj nyob hauv teb chaws Meskas.
